Special Notices:

1. All cadets must have signed (two sided) parental consent form
2. Bring **\$20** to help defray the cost of food this month's drill.
3. (PT) gear: Running Shoes, white socks, shorts, white t-shirt or any USNSCC T-shirt.
4. All hands need to bring a copy of this POD to drill. Also, a chronometer is encouraged.
5. If your ID Card has expired or if it will expire prior to April 2019, you will need to bring a check in the amount of \$100.00 for re-enrollment. This will ensure that you have a current ID Card.

Standing Orders

1. The attire for cadets who havn't received uniforms is dark dress shoes or boots, dark socks, dark blue "dickie" style trousers, belt, and plain collared shirt. No part of the cadet uniform is worn until all parts can be worn appropriately.
2. The USNSCC ID must be on your person at all times while at drill period including travel.
3. No gear shall be unattended unless secured in authorized storage for station security reqs.
4. Cadets may not operate motor vehicles with other non-family cadets while on station.

5. No cadet may leave drill for any reason, including with adult supervision, without permission of the Command Duty Officer or the Executive Officer.
6. Cadets are reminded that 80% drill attendance is mandatory in the US Naval Sea Cadet Corps. At least 1 summer training, and completion of 1 coursework per year is mandatory in the 2745th Seabee Battalion.
